- Chuck Washington County Detention Center chaplain is requesting more literature. Well we gave them last time is running low or gone.
- Todd Do they still want us to go into the facility?
- Chuck Security protocols prevent them from having groups of cell blocks come together. We would have to go into each cell and there is not mandatory attendance. People in the cell are still going about their day while others may want a meeting. There are currently only three approved volunteers that have gone through their security checks and it is difficult to get people cleared. When you do get cleared, you are listed as a "jail" Minister" and you get a badge.
- Frank When any facility reaches out for literature, I wouldn't want to turn them down. I would like to see a motion to get some literature in their hands.
- Marc We have an independent HIPPR subcommittee that we should direct to do that.
- Dyanne We need to check the HIPPR budget first. There are currently literature racks that are not being followed up on.
- Janis I have five literature racks in Fayetteville that I am filling.
- Dyanne Where are you getting the literature for those racks? From your home group?
- Janis Basically, yes.
- Dyanne At the last HIPPR subcommittee meeting we discussed that if each group sponsored a literature rack then it wouldn't fall to one or two people.
- Chris Decatur facility has new admin that contacted me about getting an NA meeting in there. They can leave but have a curfew so I'm not sure if it falls under HIPPR.
- Frank I used to go in there weekly and then less people started going into facilities in general.

- Chuck Nick was working there before and would arrange an NA speaker every Friday. Your group can do the function of HIPPR without area. Your group can sponsor that. We did a simple format with readings and a speaker.
- Jack I don't know about that jail, but they don't let inmates bring any books in with them from the outside. They have to be requested from the Chaplain.

- Chuck In house sharing of books among inmates or they have carried them home. I am trying to convince the chaplain to allow us to stamp the books so that when inmates bring them home they will be able to find a meeting.
- Chuck Final Frontier will hopefully find a new location for the Feb fundraising event. More will be revealed.
