Open Share:

• Marc - Guidance Committee met today. One of the things we were made aware of are the Guidelines and Policies state Guidelines and Policies are to be reviewed on a yearly basis. After the discussion during last month's ASC meeting regarding too many changes being brought back to the individual groups, the decision has been made to separate guidelines from procedure and policies. The reason being, anything that is a guideline for the area should be almost "written in stone" and be changed by the group conscience. Anything that is a Policy/Procedure "how we do things" should not be going back to groups every time and be voted on during ASC. The Guidance Committee with Vice-Chair takes care of these changes. Any discussion moving that direction in the next 6 months?

- Chuck clarification that we would be separating hard guidelines "skeleton of what we have and what we do" i.e, clean time requirements for example from policy and procedure that would not go back to groups for example budgets. Budgets are guidelines that would have to go back to the group for % vote and come back to ASC. This is not how this would work. Budgets need to be fluid in service to Narcotics Anonymous and the suffering addict. These would be voted on at area level so groups can focus on their group business. ASC would vote on Policy and Procedure changes.
- Janis Reminding committee the Treasurer position is open. I do have the treasurer report for this month, and request the Treasurer position be filled as soon as possible.
- Marc If there is no more discussion on what the Guidance Committee is looking at doing, under new business, I may direct the Vice-Chair to move forward with changes we are proposing.
- Chuck Could this be appointed as an ad-hoc committee?
- Marc Yes, it could. Regarding vacant Treasurer position. We are having a problem with our Treasury, it's 2 fold. In the absence of a treasurer, we will need our vice chair to take over these duties to make sure there is continuity and accountability however, we need someone to step into this position. Right now, our guidelines state the signing authority can be the chairperson, RCM and Treasurer. I cannot be on the account due to waiting on a social security number so I am unable to be a signer on the account in the US. (at least 6 months out potentially) We need to address these things in our guidelines about the treasury. Janice has offered her support and training in the transition however, we need to make a decision today. I don't want the Guidance Committee or myself or anyone else to push forward our agenda without the body feeling this is the best decision for the area. Have I missed anything Alicia?
- Chuck B. Clarifying point. With us not having a treasurer elected and due to Marc's situation, we have 1 signer on the account, the RCM. We usually require 2 signatures on a check for anything. I believe in our former guidelines, it stated the vice chair was a signer and the vice-chair would take over duties for the sub-committee chair or in absence of another position. Along the lines of accountability with our treasury, we have nothing as to who is to be a signer on our activities account that is supposed to at times maintain over \$5000. We need to make some adjustments for the financials.
- Janis Current signers at the bank until it gets changed. Signers are currently Frank, Janis,
 Chuck. Will need to be changed at the bank. I also have a key to the post office box in Rogers.
 Janis has not been to Rogers, will need someone to take this over and check on the box.
- Marc and Alicia volunteer to check the post office box. Alicia lives nearby.
- Marc Janis could you get the key to Alicia?
- Alicia- Will get the key from Janis in order to check the post office box on her way to work.
- Janis I also have a box of literature that will need to be picked up, ordered months ago for HIPPR.
- Marc- Alicia and Marc will coordinate a pick up time with Janis to get literature and treasurer materials.
- Janis How do we go about meeting at the bank to update signatures on the account? Current signers are:
- Alicia Currently Chuck is the only person that can be on the account. Chuck can coordinate with you (Janis) to get you and Frank off the account until a new Treasurer has filled the position..
 Marc - We can discuss who can be a co-signer in new business today.

• Marc - In regards to Beaver Roundup, there has been a suggestion that 2 items be addressed. Accountability for the activities bank account as addressed by Chuck and communication by Frank that he has willingness to continue organizing BRU. The Guidance Committee suggests Beaver Roundup be organized under the Activities committee chair even if the BRU is the only activity taking place through the course of the year. The other part is in regard to the same people doing the same activity/ tasks each year. We may direct in a motion today, if the will of the group approves, to direct the activities sub-committee to create a task list and a timeline in the event anything ever happens to those people planning the activity and the knowledge they have in organizing BRU is not lost. For example; in January we do this, we order food during this time, etc.

New Business:

- Marc As chair, I am appointing an ad-hoc committee for the duration of 1 year appointing
 vice-chair as chair of the ad-hoc committee to review guidelines with the guidance committee and
 anyone else who would like to join. Intent is to separate guidelines from policies and procedures.
- Chuck Would like to point out something in our guidelines under "Vacancies";
 - a. Notice of intent to fill a vacancy shall be provided at a regularly scheduled NWAASC meeting.
 - b. Elections to fill a vacancy of an office shall occur within two regular NWAASC meetings after the vacancy arises. When an office is vacant, and there is no one willing or able to serve, the duties of the vacant position shall be assigned to another trusted servant as recommended by the NWAASC Chairperson when the vacant position is an officer and as recommended by the NWAASC Vice Chairperson when the vacant position is a standing subcommittee Chairperson.
- Marc I am waiting to hear back from Frank to see if he has the willingness to be Activities chair even if BRU is the only activity planned for the year.
