BMLT: All meetings have been updated that we have received. There is currently an audit of meetings that are not currently connected with an ASC or as a Loner group with the RSC. I have made connections with some smaller communities and was able to get a few meetings updated that are still alive and thriving in rural Arkansas. This work is not done, but should be wrapped up in the next couple weeks.

Phoneline: Update to the patch list has been done to include the volunteers that were present at the last RSC workshop. There are several other volunteers on the list and it is unknown when they were each last trained. I have been going through to update that information as well. It will be completed by the next RSC. We had a charge of \$10.05 for the cost of using the phone number in addition to the monthly charge of the answering service that totals \$426.15 for the quarter (includes June, July, & Aug).

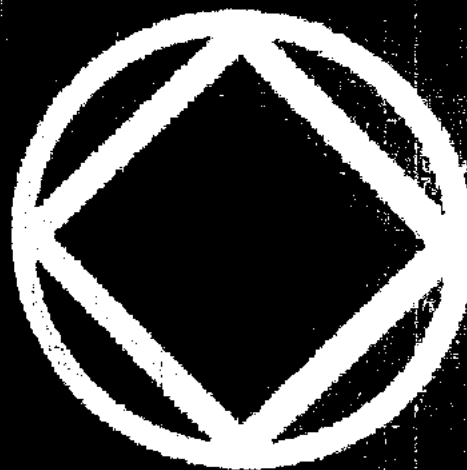
