Worthy Notes

- RD - Our Regional Delegate, Glynn W, has resigned due to health issues, this has left the RD position open. Our AD, Alicia A., has the willingness and has been nominated. Please bring any other nominations to me. *Note: This will leave the AD position available if Alicia A. is elected, so if we have any nominations for this position, please bring them as well. We will elect RD at Feb RSC.
- Treasurer was turned over to David D and an audit was performed. There were small accounting errors but all monies came out correct.
- Policy and Procedure - Guidelines have been handed out for the year with all addendums added to the correct spot from the last 2 years of motions.
- Communications Coordinator - submit an event directly to ARSCNA.org and option to add to your calendar. All meetings and events have been updated on site. Meetings on BMLT have been updated to current that have been received. Regional phone line was not working from July to Nov due to an address issue. It has been restored. Noted that NWA gets the most calls but our people usually do not answer and it gets patched to another location.
- Convention chair elected - Chuck B - He has been given authority to sign the contract for the hotel and coffee. Also any other contracts that need to be signed to keep the project moving.
- Inmate Correspondence - Letters printed, labels created. Basic Texts and a letter will be sent to any incarcerated persons that write to the Region. Not to exceed \$150 per quarter.
- Regional Inventory - Received 9 responses, will compile information and report back next RSC.

- Basic Text for Jails - SZF doesn't have the capacity to help with the project after seeing the manpower that needs to go into the project. Asking if the Region has the capacity and willingness to take the lead. We voted yes, we do however have the question of "Will they return the monies provided to SZF from RSC to complete the project?" Violet A. has the willingness to lead the project - If interested in helping contact Crystal S.
- Insurance for the region project ADHOC chair, David C, has stepped down, running in circles. Alicia A is picking it up.

Back to Areas Motions

M2024-11-03: Update the RSC guidelines and Policies & Procedures to update all references to: "Regional Delegate Alternate" or RDA, replacing them with "Alternate Delegate" or AD.

○ INTENT: To bring our Guidelines and Policy & Procedures more current and aligning with the Guide to World Services. This is the terminology that has been adopted for the World Service Conference. BACK TO AREAS

M2024-11-04: Add a line item in our budget for RD WSC travel that is equivalent to the amount we accrue for the Alternate Delegate to travel to the 2026 WSC. This will allow us to save the amount of the next 16 months before the 2026 WSC.

○ INTENT: Regions can now elect to have WSC travel for their RD paid or they can elect to cover the cost themselves. Regions who can provide this financial support to their RD lessens the financial burden on NAWS for WSC travel. BACK TO AREAS

○ Note to areas: This would be \$250 budgeted quarterly and \$3000 maximum over the course of two years.

M2024-11-08: To eliminate phoneline and divert human and financial resources to social media and website development and management.

○ INTENT: Reflect social norms and to be more financially prudent, enabling broader outreach. BACK TO AREAS
